5400 Brodie	Theft	Male arrested after stealing a pair of shoes

Home Depot Blvd	Recovered Stolen Vehicle	City cameras alerted officers to a vehicle stolen out of Austin. Officers arrested the driver and recovered the stolen vehicle
4805 Hwy 290	Theft	Male arrested after concealing merchandise in a computer case.
4805 Hwy 290	Theft/Criminal Trespass	Male who was previously issued a notice of trespass from a store was arrested after returning to the store and stealing shoes
5207 Brodie Ln	Theft	Two females stole merchandise and then fled out of a rear store exit

5800 Brodie Ln	Recovered Stolen Vehicle	City cameras alerted officers to a vehicle that was reported stolen out of Austin. The driver was arrested
5400 Brodie Ln	Theft/Delivery of Controlled Substance/Unlawful Carry of Weapon	Officers contacted a male inside of a vehicle that was unlawfully parked in a handicapped space. Officers later discovered that the male had an outstanding warrant. Upon searching the male and vehicle officers found a stolen pistol and bags of white crystal substances believed to be controlled substances
Pillow Rd	Information	Resident found blood in bathroom sink leading her to believe that unknown persons entered the home without permission
4000 Blk Hwy 290	Recovered Stolen Vehicle	City cameras alerted officers to a stolen vehicle. Officers stopped the vehicle and arrested the driver.
